- 2. Article 8: R2 Medium Density Residential: Allow single family dwellings to be located in a Medium Density Residential district.
- 3. Article 10: C: Commercial: Sec. 3.10.02 Allow playfields such as soccer, football and similar to be located in a Commercial district.
